- Pursuant to the Amended and Restated Agreement and Plan of Merger and Reorganization, dated as of August 1, 2014 (Merger Agreement?), by and among Yuma Energy, Inc., a Delaware corporation (Old Yuma?), Pyramid Oil Company, a California corporation (New Yuma?), Pyramid Delaware Merger Subsidiary, Inc., and Pyramid Merger Subsidiary, Inc. (Merger Sub?), Merger Sub merged with and into Old Yuma (Merger?). Upon the effective time of the Merger, each share of common stock of Old Yuma was cancelled and exchanged for 757.34 shares of New Yuma common stock.
- Outstanding Old Yuma restricted stock awards were assumed by New Yuma pursuant to the Merger Agreement and replaced with New Yuma restricted stock awards. Each share of Old Yuma restricted stock was exchanged for approximately 757.34 shares of New Yuma restricted stock.
- The New Yuma restricted stock award vests as to 244,370 shares of New Yuma common stock on April 1, 2015, as to 14,140 shares on May 20, 2015, as to 31,301 shares on December 31, 2015, as to 14,140 shares on January 1, 2016, and as to 14,132 shares on January 1, 2017.
