(a) Financial Statements of Businesses Acquired.

As previously reported in our Current Report on Form 8-K filed on December 7, 2007 (the Prior Filing), CSS Industries, Inc. (we , our), through its wholly-owned subsidiary C.R. Gibson, LLC (f/k/a Delta Acquisition, LLC), completed the acquisition of substantially all of the business and assets of C.R. Gibson, Inc., a designer, marketer and distributor of memory books, stationery, journals and notecards, paper tableware, infant and wedding photo albums and scrapbooks and other gift items that commemorate life s celebrations, on December 3, 2007.
