The purpose of this Amendment 1 to Schedule 13G is to correct the initial Schedule 13G filed for MBIA, Inc. on January 26, 2016. Due to an internal processing error, beneficial ownership of 8,000,000 shares of MBIA, Inc. common stock (1) was attributed to Cutwater Investor Services Corporation (Cutwater), and (2) due to the involved parent-subsubsidiary relationships, also was attributed to Cutwater Holdings, LLC (Cutwater Holdings) and The Bank of New York Mellon Corporation (BNY Mellon). At no time did Cutwater, Cutwater Holdings or BNY Mellon have direct or indirect power to vote or direct the vote of, or the power to dispose or direct the disposition of, these 8,000,000 shares; each of these firms disclaims beneficial ownership over these 8,000,000 shares.

The amount beneficially owned includes, where appropriate, securities not outstanding which are subject to options, warrants, rights or conversion privileges that are exercisable within 60 days. The securities reported herein as beneficially owned may exclude securities of the issuer with respect to which voting and/or dispositive power is exercised by subsidiaries of The Bank of New York Mellon Corporation, or departments or units thereof, independently from the exercise of those powers over the securities reported herein. See SEC Release No. 34-39538 (January 12, 1998).
