We have examined management's assertion, included in the accompanying Management Statement Regarding Compliance With Certain Provisions of the Investment Company Act of 1940, that Equus Total Return, Inc. (the "Fund") complied with the requirements of subsections (b) and (c) of Rule 17f-2 under the Investment Company Act of 1940 (the "Act") as of December 21, 2017. Management is responsible for the Fund's compliance with those requirements. Our responsibility is to express an opinion on management's assertion about the Fund's compliance based on our examination.

Included among our procedures were the following tests performed as of December 21, 2017 and with respect to agreement of security purchases and sales, for the period from October 30, 2017 (the date of our last examination) through December 21, 2017:

- Count and inspection of all securities located in the vault of the Amegy Bank (the "Custodian") in Houston, Texas without prior notice to management;
- Confirmation of all securities hypothecated, pledged, placed in escrow, or out for transfer with brokers, pledgees, or transfer agents; and
- Reconciliation of all such securities to the books and records of the Fund and the Custodian.

We believe that our examination provides a reasonable basis for our opinion. Our examination does not provide a legal determination on the Fund's compliance with specified requirements.

In our opinion, management's assertion that the Fund complied with the requirements of subsections (b) and (c) of Rule 17f-2 of the Act as of December 21, 2017 with respect to securities reflected in the investment account of the Fund is fairly stated, in all material respects.
