On May 14, 2009 each of the Company's non-employee directors received a grant of 8,840 deferred stock units (DSUs) under the Company's 2005 Equity Incentive Plan. Each DSU represents a right to receive one share of Cameron common stock at the end of the (1) deferred period. The grant vests in four equal quarterly increments on August 14, 2009, November 14, 2009, February 14, 2010, and May 14, 2010. The deferral period runs through May 14, 2012 unless further deferred by the recipient, or upon termination of board service, whichever date is the first to occur.
