One Hundred Thousand (100,000) shares of Common Stock have been previously registered for issuance under the Plan on the Company's Registration Statements on Form S-8 (Registration No. 333-53739 filed on May 28, 1998, Registration No. 333-108152 filed on August 22, 2003, and Registration No.333-159431 filed on May 22, 2009 (collectively, the "Prior Registration Statements")). This Registration Statement relates to securities of the same class as those to which the Prior Registration Statements relate and is submitted in accordance with Section E of the General Instructions to Form S-8 regarding Registration of Additional Securities. Pursuant to Section E of the General Instructions to Form S-8, the contents of the Prior Registration Statements are incorporated herein by reference and made part of this Registration Statement, except as amended hereby.
