<b>Call Level</b>	100% of the Starting Value
<b>Observation Dates</b>	Approximately one year and two years from the pricing date
<b>Call Amount</b>	[\$11.20 to \$11.30] if called on the first Observation Date and [\$12.40 to \$12.60] if called on the second Observation Date, each to be determined on the pricing date
<b>Payout Profile at Maturity</b>	If the Market Measure is flat or increases up to the Step Up Value, a return equal to the Step Up Payment  If the Market Measure increases above the Step Up Value, a return equal to the percentage increase in the Market Measure
<b>Step Up Value</b>	1-to-1 downside exposure to decreases in the Market Measure, with up to 100% of your principal at risk 130% of the Starting Value
<b>Step Up Payment</b>	\$3.00 per unit, a 30% return over the principal amount
<b>Threshold Value</b>	100% of the Starting Value
