(3) One-third of the restricted stock units vest on each of the first, second, and third anniversaries of the date of grant.

(4) The option to purchase 39,506 shares of common stock was awarded under the Post Holdings, Inc. 2016 Long-Term Incentive Plan in a transaction exempt under Rule 16b-3 and vest in equal increments over three years.
