Sabby Management, LLC, a Delaware limited liability company, indirectly owns 5,397,615 shares of Common Stock because it serves as the investment manager of Sabby Healthcare Volatility Master Fund, Ltd. and Sabby Volatility Warrant Master Fund, Ltd., each of which is a Cayman Islands company that directly hold 3,482,220 and 1,915,395 shares of Common Stock, respectively. Mr. Mintz indirectly owns 5,397,615 shares of Common Stock in his capacity as manager of Sabby Management, LLC.
