Results of Annual Meeting of Stockholders

On December 11, 2018, Centric Brands Inc. (the "Company") filed with the U.S. Securities and Exchange Commission its definitive proxy statement for the Company's 2018 annual meeting of stockholders held on December 31, 2018 (the "Annual Meeting").

The Board of Directors fixed the close of business on November 7, 2018 as the record date for identifying those stockholders entitled to notice of, and to vote, at the Annual Meeting. On December 13, 2018, the notice of Annual Meeting, definitive proxy statement and proxy card for the Annual Meeting were first mailed to stockholders along with the Company's Annual Report on Form 10-K for the fiscal year ended December 31, 2017. On December 31, 2018, the Company conducted its Annual Meeting and all proposals were approved pursuant to the applicable voting standard for each proposal as described in the Company's definitive proxy statement.
