- (1) Restricted stock units convert into common stock on a one-for-one basis.
On December 19, 2017, the reporting person had 273 shares withheld and cancelled to cover minimum required tax withholdings due to the vesting of restricted stock units. These share cancellations are shown on Table I as dispositions (Transaction Code "D" in Column 4), although none of these cancelled shares were sold into the market, as indicated by Transaction Code "F" in Column 3.
- (3) The NFG stock fund under the NFG 401(k) plan is denominated in units, representing ownership interests in a fund that includes both NFG common stock and a reserve of cash. The information reported represents the dollar value of the reporting person's balance in the NFG stock fund as of December 19, 2017, as reported by the plan administrator, divided by the closing price of NFG common stock on that date.

- (4) On December 19, 2014, the reporting person was granted 1,587 restricted stock units, vesting as follows: 529 on December 19, 2015, 529 on December 19, 2016, and 529 on December 19, 2017.
- (5) Each restricted stock unit represents a contingent right to receive one share of NFG common stock.
- (6) The restricted stock units vest as follows: 733 on December 20, 2018, 733 on December 20, 2019, and 734 on December 20, 2020.
