Northwest Natural Gas Company ("Issuer") will provide upon request by the Commission staff or a security holder of the Issuer full information regarding the number of shares purchased or sold at each separate price.

- (3) Shares held in reporting person's account under Issuer's Retirement K Savings Plan as of July 31, 2018.  
Includes 1,551 of 3,100 RSUs granted under issuer's Long Term Incentive Plan. The 3,100 RSUs vest in three installments: 775 shares on each March 1, 2019 and 2020, and 1,550 shares on March 1, 2021. Reporting person has previously elected that 50% of shares received on vesting of RSUs, or an aggregate of 1,551 shares, will be deferred under the issuer's Deferred Compensation Plan for Directors and Executives.
- (4) Shares have been credited to reporting person's account under the Issuer's Deferred Compensation Plan for Directors and Executives.
- (5) The option vested in four equal installments on February 25, 2010, and January 1, 2011, 2012 and 2013.
- (6) Option was granted as part of compensation for services. The option was exercised as a cashless exercise.
