Item 8.01. Other Events.

Since November 3, 2017, Physicians Realty Trust (the "Company"), through subsidiaries of its operating partnership, Physicians Realty L.P. (the "Operating Partnership"), acquired seven medical office facilities, located in four states containing an aggregate of approximately 938,831 net leasable square feet, and purchased the remaining ownership interest in a 22,948 square foot medical office facility located in Arizona that it partially owned for an aggregate purchase price of approximately \$356.8 million. Additionally, on December 18, 2017, the Company, through a subsidiary of its Operating Partnership, completed the sale of a 20,939 square foot medical office building located in Nebraska for approximately \$2.5 million, recognizing a gain on the sale of approximately \$0.8 million.
