Investors should be willing to forgo interest and dividend payments and be willing to lose up to 85.00% of their principal amount at maturity.

The Notes are unsecured and unsubordinated obligations of JPMorgan Chase Financial Company LLC, which we refer to as JPMorgan Financial, the payment on which is fully and unconditionally guaranteed by JPMorgan Chase & Co. **Any payment on the Notes is subject to the credit risk of JPMorgan Financial, as issuer of the Notes, and the credit risk of JPMorgan Chase & Co., as guarantor of the Notes.**

## Hypothetical Payout Profile

The following graph demonstrates hypothetical payments at maturity on the Notes for a sub-set of Index Returns detailed in the table above (-50% to 50%). We cannot give you assurance that the performance of the performance of the Index will result in the return of any of your principal amount in excess of \$150.00 per \$1,000 principal amount Note, subject to the credit risks of JPMorgan Financial and JPMorgan Chase & Co.

#### How the Notes Work

##### **Upside Scenario:**

If the Final Value is greater than or equal to the Initial Value, investors will receive at maturity the \$1,000 principal amount *plus* a return equal to the greater of (a) the Contingent Minimum Return of at least 20.50% and (b) the Index Return.

Assuming a hypothetical Contingent Minimum Return of 20.50%, if the closing level of the Index increases 10.00%, investors will receive at maturity a 20.50% return, or \$1,205.00 per \$1,000 principal amount Note.

Assuming a hypothetical Contingent Minimum Return of 20.50%, if the closing level of the Index increases 30.00%, investors will receive at maturity a 30.00% return, or \$1,300.00 per \$1,000 principal amount Note.

##### **Par Scenario:**

If the Final Value is less than the Initial Value by up to the Buffer Amount of 15.00%, investors will receive at maturity the principal amount of their Notes.

##### **Downside Scenario:**

If the Final Value is less than the Initial Value by more than the Buffer Amount of 15.00%, investors will lose 1% of the principal amount of their Notes for every 1% that the Final Value is less than the Initial Value by more than the Buffer Amount.

For example, if the closing level of the Index declines 60.00%, investors will lose 45.00% of their principal amount and receive only \$550.00 per \$1,000 principal amount Note at maturity.

We and our affiliates play a variety of roles in connection with the Notes. **NON-U.S. SECURITIES RISK —**

The internal funding rate used in the determination of the estimated value of the Notes is based on, among other things, our and our affiliates' view of the funding value of the Notes as well as the higher issuance, operational and ongoing liability management costs of the Notes in comparison to those costs for the conventional fixed-rate debt of JPMorgan Chase & Co. The use of an internal funding rate and any potential changes to that rate may have an adverse effect on the terms of the Notes and any secondary market prices of the Notes. **THE VALUE OF THE NOTES AS PUBLISHED BY JPMS (AND WHICH MAY BE REFLECTED ON CUSTOMER ACCOUNT STATEMENTS) MAY BE HIGHER THAN THE THEN-CURRENT ESTIMATED VALUE OF THE NOTES FOR A LIMITED TIME PERIOD —**

We generally expect that some of the costs included in the original issue price of the Notes will be partially paid back to you in connection with any repurchases of your Notes by JPMS in an amount that will decline to zero over an initial predetermined period. Any secondary market prices of the Notes will likely be lower than the original issue price of the Notes because, among other things, secondary market prices take into account our internal secondary market funding rates for structured debt issuances and, also, because secondary market prices (a) exclude selling commissions and (b) may exclude projected hedging profits, if any, and estimated hedging costs that are included in the original issue price of the Notes. ## Historical Information

The following graph sets forth the historical performance of the Index based on the weekly historical closing levels of the Index from January 3, 2014 through February 22, 2019. The closing level of the Index on February 27, 2019 was 3,282.77. We obtained the closing levels above and below from the Bloomberg Professional<sup>®</sup> service (“Bloomberg”), without independent verification.

The historical closing levels of the Index should not be taken as an indication of future performance, and no assurance can be given as to the closing level of the Index on the Initial Valuation Date or the Final Valuation Date. ## Tax Treatment

Based on current market conditions, in the opinion of our special tax counsel it is reasonable to treat the Notes as “open transactions” that are not debt instruments for U.S. federal income tax purposes, as more fully described in “Material U.S. Federal Income Tax Consequences — Tax Consequences to U.S. Holders — Notes Treated as Open Transactions That Are Not Debt Instruments” in the accompanying product supplement. Assuming this treatment is respected, the gain or loss on your Notes should be treated as long-term capital gain or loss if you hold your Notes for more than a year, whether or not you are an initial purchaser of Notes at the issue price. However, the IRS or a court may not respect this treatment, in which case the timing and character of any income or loss on the Notes could be materially and adversely affected. In addition, in 2007 Treasury and the IRS released a notice requesting comments on the U.S. federal income tax treatment of “prepaid forward contracts” and similar instruments. The notice focuses in particular on whether to require investors in these instruments to accrue income over the term of their investment.
