(1) On May 17, 2013, the reporting person exercised 12,500 stock options, delivered 5,548 shares of Common Stock of the Company for cancellation in payment of the exercise price of such options, and had 2,569 shares of Common Stock of the Company withheld and cancelled to cover minimum required tax withholding.
