- (1) The reported price in Column 4 is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$41.500 to \$41.775, inclusive. - (2) On December 22, 2015, the reporting person had 932 shares withheld and cancelled to cover minimum required tax withholdings due to the vesting of restricted stock units.
