(1) On May 16, 2007 the Issuer granted the reporting person 1,730 Restricted Stock Awards (RSAs) under the First Midwest Bancorp, Inc. Omnibus Stock Incentive Plan (Plan). On May 18, 2009, 865 shares of the originally granted RSAs vested, of which 309 shares were surrendered by the reporting person in order to satisfy tax withholding obligations.
