The option vests if the Company's stock price achieves certain targets within specified timeframes as follows: one-fourth shall vest if Fair Market Value of the Company's stock achieves \$64.90, but not earlier than 1/1/08; one-fourth shall vest if Fair Market Value of the Company's stock achieves \$69.54, but not earlier than 5/1/08; one-fourth shall vest if the Fair Market Value of the Company's stock achieves \$75.34 but not earlier than 5/1/09; and one-fourth shall vest if the Fair Market Value of the Company's stock achieves \$81.13 but not earlier than 5/1/10. All options not other wise vesting pursuant to the above timetable shall become exercisable on May 24, 2011.
