 The phantom stock units are accrued under the Renasant DSU Plan. The units are settled 100% in the Company's common stock upon the
 (2) reporting person's retirement or upon approved hardship reasons. The conversion or exercise price is one phantom stock unit for one share of the Company's common stock.
 Beginning with the issue date, equal installments of 33 1/3 of the option shares granted will be available for exercise upon completion of
 (3) one, two, and three years of service measured from date of grant, respectively. The options expire ten (10) years from the grant date.
