Incentive Compensation Plan Performance Goals and Target Payments

On July 31, 2014, the Board of Directors of Key Tronic Corporation (“Company”), upon the recommendation of its Compensation Committee, established the performance goals and target payment percentages for each participant in the incentive compensation plan (“Plan”) for the Company’s fiscal year 2015.

A minimum Company profit goal must be achieved in order for any payments to be made to participants in the Plan. Payments under the Plan for fiscal year 2015 will be based on three profit goal performance levels established by the Board: entry level, expected value level and overachievement level. Payments under the Plan will be a percentage of the participant’s base salary paid during fiscal year 2015.

The following executive officers of the Company are among the participants in the Plan: Craig D. Gates, President & CEO; Ronald F. Klawitter, Executive Vice President of Administration, CFO and Treasurer; Douglas G. Burkhardt, Executive Vice President of Worldwide Operations; Philip S. Hochberg, Executive Vice President of Business Development; and Brett R. Larsen, Vice President of Finance and Controller. Under the Plan the potential payment percentages established by the Board for fiscal year 2015 for the President & CEO range from 5% of base salary paid during fiscal year 2015 if entry level performance is achieved to 75% if overachievement level performance is achieved. The potential payment percentages established by the Board for fiscal year 2015 for the Executive Vice President of Administration, CFO and Treasurer, the Executive Vice President of Worldwide Operations, and the Executive Vice President of Business Development range from 4% of base salary paid during fiscal year 2015 if entry level performance is achieved to 60% if overachievement level performance is achieved. The potential payment percentages established by the Board for fiscal year 2015 for the Vice President of Finance and Controller range from 3.5% of base salary paid during fiscal year 2015 if entry level performance is achieved to 52.5% if overachievement level performance is achieved. Payment percentages will be interpolated for actual performance levels achieved between entry level and expected value level and between expected value level and overachievement level.

Payments under the Plan will be made as soon as administratively possible after the end of fiscal year 2015. A participant must be an active employee of the Company at the time payments are made under the Plan in order to receive a payment.

Fiscal Years 2015-2017 Long-Term Incentive Plan Performance Measures and Awards

On July 31, 2014, the Board of Directors upon recommendation of its Compensation Committee, established long term incentive plan performance measures for the three fiscal year period 2015 through 2017. The Board of Directors also approved target awards for the three year period for each of the Company’s officers and non-employee Directors. The fiscal 2015-2017 performance measures are based on a combination of sales growth targets compared to the industry and return on invested capital targets. No cash awards will be made to participants if actual Company performance does not exceed the minimum target performance measures. The payments after the end of fiscal year 2017 to each of the named executive officers for the three year performance period, if expected target performance measures are achieved, are as follows: Craig D. Gates, President and CEO - \$300,000, Ronald F. Klawitter, Executive Vice President of Administration, CFO and Treasurer - \$180,000, Douglas G. Burkhardt, Executive Vice President of Worldwide Operations - \$110,000, Philip S. Hochberg, Executive Vice President of Business Development - \$110,000 and Brett R. Larsen, Vice President of Finance and Controller - \$50,000. The payment after the end of fiscal year 2017 to each non-employee Director of the Company for said three year period, if expected target performance measures are achieved, is \$20,000. Actual cash payments to participants under the target awards may be as much as 100% less than the target award amounts or as much as 50% greater than the target award amounts depending on the extent to which Company performance is less than or exceeds the expected target performance measures.
