The Registrant has not filed its Annual Reports on Form 10-KSB for the years ended December 31, 2004 and 2005 for a number of reasons, including the following primary reasons: (1) The Registrant lacks the financial resources to engage an independent registered public accountanting firm to conduct an audit of the related financial statements. Via letter dated March 29, 2006, its former independent registered public accountanting firm, Hausser + Taylor LLC, informed the Registrant and the SEC of their decision to resign as auditor. (2) The Registrant lacks the staffing to prepare the Forms 10-KSB due in large part to the amount of time management has devoted and the amount of funds the Registrant has spent in responding to litigation.

For the same reasons, the Registrant has been unable to file its Quarterly Reports on Form 10-QSB for March 31, 2005, June 30, 2005 and September 30, 2005, nor will it be able to file its Quarterly Report on Form 10-QSB for March 31, 2006 by the extended due date. The Registrant will use its best efforts to file the Forms 10-KSB and Forms 10-QSB as soon as its financial resources and staffing permit. The Registrant, however, is unable to predict when it will be able to make these filings and there can be no assurance that the filings will be made at all.
