Hanson Qualified Terminable Interest Property Marital Deduction Trust (the "QTIP Trust"), the Luise V. Hanson Revocable Trust dated September 22, 1984 (the "Revocable Trust") and John V. Hanson, Mary Joan Boman and Paul D. Hanson, (1) each in their individual capacity. John V. Hanson, Mary Joan Boman and Paul D. Hanson are the Managing Members of HCP. John V. Hanson, Mary Joan Boman, Paul D. Hanson and Bessemer Trust Company, N.A. are co-trustees under the QTIP Trust and the Revocable Trust which have a 34.8% and 64.6% membership interest in HCP, respectively. John V. Hanson, Mary Joan Boman and Paul D. Hanson each have, in their individual capacity, a .2% membership interest in HCP.
