Mr. Cohen controls each of SAC Capital Advisors Inc. and Sigma Management. As of December 31, 2010, by reason of the provisions of Rule 13d-3 of the Securities Exchange Act of 1934, as amended, each of SAC Capital Advisors LP, SAC Capital Advisors Inc. and Mr. Cohen may be deemed to beneficially own 6,412 Shares (constituting less than 0.1% of the Shares outstanding).
