Glenview Capital Management serves as investment manager to each of Glenview Capital Partners, Glenview Capital Master Fund, Glenview Institutional Partners, Glenview Offshore Opportunity Master Fund, and Glenview Capital Opportunity Fund. Mr. Robbins is the Chief Executive Officer of Glenview Capital Management.

This amount consists of: (A) 251,791 Shares, and 129,600 Shares obtainable upon exercise of options, held for the account of Glenview Capital Partners; (B) 2,921,494 Shares, and 1,488,500 Shares obtainable upon exercise of options, held for the account of Glenview Capital Master Fund; (C) 1,423,874 Shares, and 708,600 Shares obtainable upon exercise of options, held for the account of Glenview Institutional Partners; (D) 2,328,823 Shares, and 1,027,700 Shares obtainable upon exercise of options, held for the account of Glenview Offshore Opportunity Master Fund; and (E) 1,760,188 Shares, and 759,800 Shares obtainable upon exercise of options, held for the account of Glenview Capital Opportunity Fund.
