DIANA SHIPPING INC. ANNOUNCES TIME CHARTER  
CONTRACT FOR M/V NEW ORLEANS WITH CARGILL

ATHENS, GREECE, April 10, 2019 – Diana Shipping Inc. (NYSE: DSX), (the “Company”), a global shipping company specializing in the ownership of dry bulk vessels, today announced that, through a separate wholly-owned subsidiary, it has entered into a time charter contract with Cargill International S.A., Geneva, for one of its Capesize dry bulk vessels, the m/v New Orleans. The gross charter rate is US\$15,000 per day, minus a 4.75% commission paid to third parties, for a period of about sixteen (16) months to about nineteen (19) months. The charter commenced earlier today.

The “New Orleans” is a 180,960 dwt Capesize dry bulk vessel built in 2015.

This employment is anticipated to generate approximately US\$6.98 million of gross revenue for the minimum scheduled period of the time charter.

Upon completion of the previously announced sale of one Panamax dry bulk vessel, the m/v Dione, Diana Shipping Inc.’s fleet will consist of 46 dry bulk vessels (4 Newcastlemax, 14 Capesize, 5 Post-Panamax, 5 Kamsarmax and 18 Panamax). As of today, the combined carrying capacity of the Company’s fleet, including the m/v Dione, is approximately 5.6 million dwt with a weighted average age of 9.29 years. Diana Shipping Inc. is a global provider of shipping transportation services through its ownership of dry bulk vessels. The Company’s vessels are employed primarily on medium to long-term time charters and transport a range of dry bulk cargoes, including such commodities as iron ore, coal, grain and other materials along worldwide shipping routes.
