- (1) 22,386 shares are held in an account in Mr. Dallas' name at Computershare, of which 250 shares are dividend reinvestment shares.
- (2) 4,700 restricted stock shares are held in an account at Computershare, which have future vesting dates. An additional 406 shares are dividend reinvestment shares, for a total of 5,106 shares.
- (3) 169,985 shares are held in an account at Computershare, of which 7,273 shares are dividend reinvestment shares. An additional 1,491,310 shares are held in a brokerage account and 6,956 shares are in certificate form.
