*On October 27, 2006, the Reporting Person acquired the following securities from the Issuer in a private placement transaction: (i) 615,385 shares of Common Stock, (ii) a Series A Warrant to purchase 123,077 shares of common stock expiring October 27, 2011 at an exercise price of \$3.58 per share, (iii) a Series B Warrant to purchase 123,077 shares of common stock expiring October 27, 2011 at an exercise price of \$4.88 per share. On December 5, 2006, the Reporting Person acquired the following securities from the Issuer in a private placement transaction: (i) 769,231 shares of common stock, (ii) a Series A Warrant to purchase 153,847 shares of common stock expiring December 5, 2011 at an exercise price of \$3.58 per share, (iii) a Series B Warrant to purchase 153,847 shares of common stock expiring December 5, 2011 at an exercise price of \$4.88 per share.
