Item 5.03 Amendments to Articles of Incorporation or Bylaws; Change in Fiscal Year.

On December 12, 2007, the Board of Directors of MACC Private Equities, Inc. (the "Company") adopted a resolution approving certain amendments to the bylaws of the Company. The Company adopted the bylaws, as amended and restated, in order to allow for the issuance of uncertificated stock in accordance with NASDAQ Rule 4350(1) (the "Rule"). The Rule requires listed securities to be eligible for a Direct Registration Program ("DRP"). A DRP permits a stockholder's ownership to be recorded and maintained on the books of the issuer or its transfer agent without issuance of a physical stock certificate.

A copy of the Company's bylaws, as amended and restated on December 12, 2007, is included as an exhibit to this report.
