Item 5.07 Submission of Matters to a Vote of Security Holders

On May 15, 2013, Great Southern Bancorp, Inc. (“Bancorp”) held its Annual Meeting of Stockholders. Of the 13,611,056 shares entitled to vote at the meeting (without reduction for the 10% voting limitation in Bancorp’s charter), 12,212,481 were present at the meeting in person or by proxy. The results of the meeting, which exclude 774,329 shares beneficially owned in excess of the 10% voting limitation by the persons believed by Bancorp to be subject to that limitation, are as follows:

1) Election of three directors, each for a term of three years:

2) Approval of the Great Southern Bancorp, Inc. 2013 Equity Incentive Plan:

The vote required to approve this proposal was the affirmative vote of a majority of the votes cast on the proposal. Accordingly, this proposal was approved.

3) Ratification of the appointment of BKD, LLP as Bancorp’s independent registered public accounting firm for the fiscal year ending December 31, 2013:
