ATTACHMENT TO PART IV OF FORM 12b-25 OF SEL-LEB MARKETING, INC.

With respect to its Form 10-KSB for the year ended December 31, 2000

Registrant made a conscious decision to restrict sales to three major customers (Bradlees, Bills Dollar Stores and Ames), whose aggregrate prior year sales with the Registrant were approximately \$1,129,000, because of the Registrant's perception that there were severe credit issues and problems with these accounts. Subsequently, both Bills Dollar Stores and Bradlees declared bankruptcy. As a result, the Registrant anticipates that it will record a loss from operations during the quarter ended December 31,2000 that substantially differs from the gain realized by the Registrant during the same period in 1999. The Registrant is in the process of determining the amount of such change in its results of operations.
