**Item 1.01 Entry into a Material Definitive Agreement.**

On March 14, 2008, Gen-Probe Incorporated (the Company ) entered into an amended and restated employment with Carl W. Hull (the Amended Agreement ). The Amended Agreement is effective as of March 1, 2008.

The Amended Agreement reflects the following previously disclosed changes to Mr. Hull s prior employment agreement: his promotion to President and Chief Operating Officer of the Company; an increased annual base salary of \$490,875; and an increase to Mr. Hull s bonus target from 50% of base salary to 60% of base salary. The Amended Agreement also provides for certain changes to comply with the requirements of Section 409A of the Internal Revenue Code of 1986, as amended.

A copy of the Amended Agreement is filed as Exhibit 99.1 hereto and is incorporated herein by reference. The foregoing description is subject to, and qualified in its entirety by, the text of the Amended Agreement.
