(1) On June 6, 2006, the Company issued its previously declared stock dividend of one share of Class A Common Stock on each share of Class A Common Stock and each share of Class B Common Stock issued and outstanding on the record date of May 22, 2006. As a result of the stock dividend, the Laura C. Yeager 1994 GST Trust received 46,794 shares of Class A Common Stock.

(2) As a result of the June 6, 2006 stock dividend, the Matthew D. Yeager 1994 GST Trust received 46,794 shares of Class A Common Stock.

(3) The reporting person disclaims beneficial ownership of these shares and this report shall not be deemed an admission that the reporting person is the beneficial owner of such securities for purposes of Section 16 or for any other purpose.

(4) 64,426 of the shares of Class A Common Stock are restricted stock subject to vesting requirements. In addition, Mr. Yeager received 292,403 shares of Class A Common Stock as a result of the stock dividend issued on June 6, 2006.

The reporting person disclaims beneficial ownership of these shares and this report shall not be deemed an admission that the reporting person is the beneficial owner of such securities for purposes of Section 16 or for any other purpose. The Yeager family members are parties to a stockholders' agreement pursuant to which they have agreed to vote all their shares of Class B Common Stock in accordance with the vote of the holders of a majority of such shares. Members of the Yeager family own all 662,296 shares of the Class B Common Stock.
