The Bank of New York Mellon Corporation, One Wall Street, New York, NY 10286, U.S.A., disclosed on September 8, 2014, that its total holding in Syngenta now amounts to 2,953,837 shares (3.18% of the total share capital), split into 2,938,799 registered shares plus purchase rights on ADRs (ISIN US87160A1007, 1 ADR=0.2 share) corresponding to 15,038 shares.
