The reporting person named herein (the Reporting Person ) as a result of the sale of shares of the Issuer since the date of the filing of the original Schedule 13D on May 26 2010 now is the beneficial owner of less than 5% of the common stock, par value \$0.001 per share (the Common Stock ) of Biolase Technology Inc., a Delaware corporation (the Issuer ) as of the event date identified on the cover page to this Schedule 13D (the Event Date ). As of the Event Date, the Reporting Person beneficially owned 1,362,150 shares of the Issuer s Common Stock which constitutes less than 5% of the total issued and outstanding shares of Common Stock outstanding as reported by the Issuer s Report filed with the Securities and Exchange Commission and had (a) sole voting and sole dispositive power with respect to said shares and (b) had no shared voting and shared dispositive power with respect to any other shares of Issuer s Common Stock. Subsequent to the Event Date the Reporting Person has not acquired additional shares of the Issuer s Common Stock.

The reduction in the amount of shares of the Issuer s Common Stock owned by the Reporting Person since the date of the original filing of Schedule 13D resulted from the sale of 200,000 shares on or about May 6 2011 and an additional 20,000 shares on or about May 12 2011, thereby reducing the amount of shares previously reported as being held from 1,582,150 to 1,362,150.
