DTE Energy Company (the Company) has an Enterprise Business Systems initiative to improve existing processes and to implement a suite of new core information systems across the enterprise including a new general ledger and work management systems. This implementation has taken place during the quarter ended June 30, 2007. The implementation of the new systems and the resulting changes in internal controls over financial reporting have resulted in delays in completing the necessary accounting work and analysis. As a result, we are not able to complete the Company's Quarterly Report on Form 10-Q for the quarter ended June 30, 2007 on or before the filing deadline with the Securities and Exchange Commission on August 9, 2007 without unreasonable effort or expense.
