**Item 1.01 Entry into a Material Definitive Agreement.**

On February 1, 2006, U.S. Concrete, Inc. (the Company ) entered into an underwriting agreement (the Underwriting Agreement ) with Citigroup Global Markets Inc., BB&T Capital Markets, a division of Scott & Stringfellow, Inc., Sanders Morris Harris Inc. and Davenport & Company LLC (collectively, the Underwriters ), relating to the issuance and sale of 8,050,000 shares of the Company s common stock (including 1,050,000 shares of the Company s common stock that were sold pursuant to the Underwriters over-allotment option). The sales were registered under the Securities Act of 1933, as amended, pursuant to the Company s shelf registration statement on Form S-3 (Registration No. 333-42860) and were made pursuant to a prospectus dated January 29, 2002, as supplemented by a prospectus supplement dated February 1, 2006. The closing of the offering of the shares, which included all the shares under the Underwriters over-allotment option, occurred on February 7, 2006. A copy of the Underwriting Agreement is filed as Exhibit 1.1 to this Report and is incorporated herein by reference.
