This prospectus supplement relates to the resale by the holders of our 1% convertible subordinated notes due August 1, 2010 and our ordinary shares issuable upon the conversion of the notes. You should read this prospectus supplement in conjunction with the prospectus dated November 26, 2003, which is to be delivered with this prospectus supplement.

As a result, the amount of ordinary shares issuable upon conversion of the notes in the future may increase or decrease.

(2) Goldman Sachs & Co. was an initial purchaser of the notes. Goldman Sachs & Co. has engaged in transactions with, and performed services for, us in the ordinary course of business and has engaged and may in the future engage in commercial banking and/or investment banking transactions with us, for which it has received or will receive, as the case may be, customary compensation. However, the notes referred to in this table were purchased by Goldman Sachs & Co. in the open market and not directly from us. Goldman Sachs & Co. previously registered \$24,395,000 principal amount of notes in Prospectus Supplement #2 dated December 24, 2003, and has registered a total of \$44,395,000 principal amount of notes.
