- (1) In accordance with the Hemisphere Media Group, Inc. (the "Company") 2013 Equity Incentive Plan (the "Plan"), the reporting person returned shares of the Company's Class A common stock to the Company for the purpose of paying the reporting person's withholding taxes due upon the vesting of restricted shares of Class A common stock previously awarded to the reporting person under the Plan. The disposition is exempt in accordance with Rule 16b-3.
- (2) This is the market price used to calculate the number of shares deducted to satisfy tax withholding obligations.
