**Item 2.02 Results of Operations and Financial Condition**

The Timken Company (the Company ) has implemented a change to its management structure and now operates under two major business groups, the Steel Group and the Bearings and Power Transmission Group, which includes three segments Mobile Industries, Process Industries and Aerospace & Defense. Beginning with the first quarter of 2008, the Company will report its financial results utilizing these four segments.
